COMPANY AND ITS LICENSORS EXPRESSLY DISCLAIM ALL OTHER WARRANTIES, EXPRESS AND IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND THOSE OTHER WARRANTY DISCLAIMERS REFERENCED IN THE SCHEDULE(S). Company does not and cannot control the flow of data to or from Company's network and other portions of the Internet. Such flow depends in large part on the performance of Internet services provided or controlled by third parties. At times, actions, or inactions of such third parties can impair or disrupt Customer's connections to the Internet (or portions thereof). No Practice of Medicine; High Risk Activities.

- i. No Practice of Medicine. Customer understands and agrees as follows:
